Terms and conditions: -

1. 5% VAT will be extra.
2. Loading and offloading time will be 3 hours for both sides, exceeding time will be charged on as pro-rata basis.

3. Accommodation and Transportation for the operator and fuel for the machine shall be provided by the hirer.
 4. If the equipment breaks down or needs service inside the site, Hirer shall arrange the pass for the mechanic or arrange for the machinery to move outside for service
 5. During the work operator will follow instructions of the supervisor, foreman, and flag man in case of any damages on the ground like cable or any other thing we are not responsible for that.
 6. If the equipment tyres get punctured hirer have to repair them.
 7. Our offer is based on the equipment working 10 hours a day, 6 days a week, and 260 hours a month, excluding Weekly holidays and public holidays. If our equipment works less than 10 hours a day, 260 hours a month due to nonavailability of work / Weekly holiday / public holidays, minimum 10 hours a day, 06 days a week, 260 hours a month will be charged. In case the equipment works more than 10 hours a day, 260 hours a month, Weekly holidays, and public holidays, it will be charged overtime on a pro-rata basis
 8. In case the equipment works for less than a month, the weekly rate will be applicable and if it isn't completed a week, a daily rate will be applicable.
 9. During the month of Ramadan, the working hours will be 8 hours/day.
 10. The Hirer shall take full responsibility and ownership of the prevailing conditions at the job site covering critical items like underground cables, water/gas pipelines, utility supply lines, hazardous elements, etc. and shall provide clear communication and necessary guidance to Operators.
1. All government related taxes/duties including company taxes, withholding taxes, duties and custom deposits / guarantees any other levies arising due to operation of equipment on site or by way of travelling to site as per the laws of the country are to be borne by the Hirer.
 2. MGT equipment will be mobilized to the site at the client's responsibility as the site inspection won't be done by MGT. If the equipment is returned back without the job done, MGT will not be responsible for any direct or indirect losses and we will claim the entire agreed rental charges against the client.
 3. MGT will not be liable or responsible for any direct or consequential loss or damage suffered by customer or any other person or any property (including equipment and materials subject of the lift), arising from breakdowns, accidents, acts or omissions of operator or any other cause whatsoever. Customer hereby indemnifies MGT in respect of any such liabilities of customer.
 4. In the event of inclement weather condition like high wind speed, sandstorms, fog, rain or any other force major, disabling our equipment from working, such period is to be considered as normal working time of the equipment. Delay of our equipment beyond the control of MGT will be charged pro rata.
 5. While on site owner's operator will be under the sole control of the customer who will supervise and give clear directions for all work to be performed by owner's operator on site and customer will be responsible for all acts or omissions of owner's operator which occur while such directions are being carried out.
 6. The customer should not request the equipment to perform any lifts beyond its rated capacity.
 7. MGT equipment and personnel are insured whereas insurance coverage of materials to be handled by our equipment is not included in our scope of work/rate and this has to be arranged by the client and/or client company with an express and unconditional waiver of subrogation towards MGT for any liabilities as a Transporter/carrier
 8. Necessary permission for our equipment and personnel at your site shall be arranged by you.
 9. **Payment : Half advance payment and after finish work .**
